Indefinite strike of RTO employees union suspended

■ NAGDA, PRASAD KUMAR:

The RTO Employees' Association had started an indefinite strike from September 24 to meet the basic demands of the employees. All the demands were discussed positively in the Transport Commissioner's office on Thursday. In this discussion, as per the demand of the organization, the entry rules for senior clerks to office superintendent posts will be finalized by 30th November 2024. A clear assurance was given that the eligible employees will be promoted up to 181 then. The policy of making transfers according to revenue department has been cancelled and it has been agreed to make transfers within 15 departments as before. The administration also agreed to take positive decisions on other demands. Accordingly, the indefinite strike has been suspended. On behalf of the organization, General Secretary Surendra Sarasate expressed his gratitude by giving a bouquet of flowers as the administration has accepted the sincere demands of the employees, and expressed his hope for similar cooperation.

'Do You Know Full Form Of MSP? Amit Shah Slams Rahul Gandhi Over Farmers' Issue In Haryana'

■ NEWARI, (AGENCIES):

Union Home Minister Amit Shah trained his guns on Congress leader Rahul Gandhi, asking if he knew the full form of MSP as he announced that the BJP government in Haryana was procuring 24 crops at the minimum support price. Addressing a rally here, Shah said that the Congress on the issue of corruption and reservation. Slaming the Congress on farmers' issue, he said some NGO has told Rahul 'baba' that by saying MSP minimum support price he will get votes. 'Rahul baba, do you know full form of MSP. Which crop is of Khairi, which one is of Rabi, do you know,' he asked Shah said the BJP government in Haryana is procuring 24 crops at MSP. 'Let Congress leaders in Haryana tell which Congress-ruled state procures as many crops,' he said. 'How many crops bought at MSP in Karnataka and Telangana,' he asked. During Congress rule, paddy was procured at Rs 1300 per quintal, now it is Rs 2500 and if you visit BJP government in Haryana, we will procure paddy at Rs 3,100 per quintal, he said. Further attacking the Congress, Shah said it was the Narendra Modi government which fulfilled the long pending demand of One Rank One Pension. Shah said the BJP undertook equal development in Haryana and corruption has finished in the last 10 years. Congress governments used to run on the basis of cut, commission and corruption while doctors, doctors (misdiagnosis) and 'damada' used to rule. Under BJP government, there are no dealers, 'balala' while there is no question of 'damad', the senior BJP leader said. Haryana goes to polls on October 5 and the results will be declared on October 8.

Fake Narrative, Vote Jihad Hurt BJP's Lok Sabha Show, Maharashtra Polls Are Different: Fadnavis At Town Hall

■ MUMBAI, SURESH CHHRE:

Maharashtra Deputy Chief Minister Devendra Fadnavis on Friday blamed 'fake narrative' by the Opposition and 'vote jihad' for the Bharatiya Janata Party's (BJP) poor show in the recent Lok Sabha elections, adding that the issues have been read and the 'ground reality is different' ahead of the state Assembly elections. Speaking at Town Hall, Fadnavis said there was a wrongfully voting. 'Vote was being put in the hands of the minorities. We undermined it. We did not think they would come together and vote. We have read it now. Today the situation on ground is different. Even minorities know that polarisation was done. People are seeing our schemes, in Mumbai, look at Metro, coastal road or Malad or even in rural areas... The narrative is in our favour.' The narrative was run in 2014 and 2019 too. It didn't work then, so we did not reply to it effectively. Maharashtra saw some impact, but overall the Maratha vote is with us. Our 43.6% is proof of that. Post poll analysis also shows that 43-46 per cent Marathas are with us. Our 52 and 57 votes were rejected. This won't happen in the Vidhan Sabha elections. 'About the plans for Assembly elections, Fadnavis said, 'We have agreed on 200 seats.' 'We don't have too many differences.'

Appeal to women who have applied under 'Chief Minister - Mahi Laddi Bahen' scheme to link their bank accounts with Aadhaar card

Under the scheme 'Chief Minister - Mahi Laddi Bahen', the women of Navi Mumbai Municipal Corporation have submitted applications. Women whose applications are eligible have received text messages (SMS) on their mobile phones. However, the benefits of the scheme have not yet been deposited in their bank accounts, such women should immediately ensure that their bank accounts are linked with Aadhaar card (Aadhaar seeded) and if Aadhaar is not linked, they should go to the concerned bank and take the process of linking the bank account with Aadhaar card immediately. A written request to Navi Mumbai Municipal Corporation appealed.

Not Eknath Shinde, We Are Fighting The BJP: Sena UBT's Aadiya Thackeray At Town Hall

Aadiya Thackeray, Shiv Sena's UBT leader, said his faction of the party was fighting for Maharashtra as the state hasn't got much in the past two years of the Bharatiya Janata Party government. Thackeray was speaking at a session titled 'Aaditya To Power In Maharashtra' at a town hall in Navi Mumbai. He said that the BJP government has not achieved anything in the past two years. They are only looking for Maharashtra. The government installed here is anti-Constitutional. They are not interested in Maharashtra. The MHA has won every election that has gone to the people. The BJP is scared of elections. 'When asked about the Supreme Court's stance on his claim that the government was unconstitutional, Thackeray said, 'The SC may take 30-40 years to deliver justice! The coastal road, due to December 2023, remains unfinished under the 'Jagat CM'. We planned blue tracks and green space - these delays are unacceptable.' Commenting on Fadnavis's remark that his party split due to his father Uddhav Thackeray's ambitions for him, Thackeray said, 'What is Devendra Fadnavis's standing in his own party? The law has leaders of the BJP government are not from the BJP. They are 2019 and 2020 imports, the CM is from the Gadgil gang... Real BJP karyakartas are not getting anything because of Fadnavis's main power struggle. The Shinde gang is not my aim. My fight is with the BJP. They broke other parties. They are dividing India and looting Maharashtra.' He added that the Sena did not expand their base in other states because of their alliance with the BJP. 'We respect our allies. We are playing cricket with Bangladesh when Hindus are being attacked there? Uddhav Thackeray led Maharashtra during Covid, he is the one who granted loan waivers. The BJP went back on its promise to us. People of Maharashtra know whom to vote to! On the infrastructure development in the state, he said, 'By the time our government was toppled, 82% work on the Karfule was completed. They started it for free months for elections. Every project Shinde has touched has been delayed.'

Saif Ali Khan Praises 'Brave Politician' Rahul Gandhi: 'He Turned Disrespect Around'

Bollywood star Saif Ali Khan has praised Rahul Gandhi, saying the Congress leader has changed people's perception about him by working hard on himself. At the India Today Mumbai Conclave 2024 on Thursday evening, the actor said he likes a politician who is honest. Asked about the politician, from Prime Minister Narendra Modi, Gandhi and AAP chief Arvind Kejriwal, who he loves and can lead India into the future, Khan said they are all 'brave politicians'. 'Khan then praised Gandhi and said he used to be disappointed for the things he used to do and say. 'I think what Rahul Gandhi has done has also been very impressive because there was a point where people were disrespecting things he was saying and things he was doing. And I think he's turned that around by working very hard. It is a very interesting way.' The 54-year-old actor said. 'Beyond that I don't want to get into a thing of who I support and what my politics is because I want to be apolitical in my outlook. And I think the country has spoken quite clearly. I'm happy about one thing. That democracy is alive and thriving in India.' He added. Khan also said he has no intention of joining politics. 'I'm not a politician. I don't really want to be a politician. And if I had strong views, I think I would become one and then share them in that way,' he said. 'I mean, you BJP journalists are really brave and much braver than me. I'm not looking for that kind of heat. But if I was, then I would go all the way through. I'm not a political party. But I'm not ready to do that yet.'

Bombay High Court Halts Disqualification of Co-op Society Member for Having Three Children

In a dramatic turn of events, the Bombay High Court has stepped in to block the disqualification of Mr. Ramchandra Newlu Zore, a Managing Committee Member of the Galaxy Complex Cooperative Housing Society Ltd. in Pune, who was disqualified for having more than two children. The interim stay, granted by Justice R. M. Janki, allows Mr. Zore to retain his position until the final judgment of W.P. Petition No. 12266 of 2024, setting the stage for a high-stakes legal showdown. The controversy erupted when Mr. Zore was elected to serve a five-year term.

Diwali-Chhath Puja 2024: 12,500 General Coaches to be Added in Special Trains This Festive Season

■ NEW DELHI, (AGENCIES):

Diwali and Chhath Puja, the festival season, the Railways has decided to increase the number of general coaches in 108 trains. The Union Railway Minister Ashwini Vaishnaw announced that general coaches will be added to 108 trains during the Diwali and Chhath Puja. The number of general coaches in 108 trains will be increased to 12,500 during Diwali and Chhath Puja. A significant number of Bharat travel home from Delhi and other parts of the country during these festivals. leading to shortage of trains, buses, and flights. As of now, more than 100 trains have been planned for this year compared to last year. All zones of Indian Railways have released a list of special trains to be operated during Diwali and Chhath. The Northern Railway will run the highest number of trains, with 130 planned. The Eastern zone has a plan for 104 special trains. The ECR zone will run 93 trains. The Indian Railways has decided to operate special trains from all zones to ensure a smooth journey for passengers.

FIR Registered Against Finance Minister Nirmala Sitharaman Over Electoral Bonds 'Extortion'

■ BANGALURU, (AGENCIES):

A case has been registered against Union Finance Minister Nirmala Sitharaman and others, on the orders of a Bengaluru Special Court, over allegations of extortion through the now-scraped electoral bonds scheme. The complaint was filed by politician Aditya Chavan, accusing Sitharaman and others of orchestrating an extortion racket under the guise of electoral bonds. The development came after a special court in Bengaluru directed local police to file an FIR against Sitharaman, who is a Rajya Sabha member from Karnataka. The complainant, Aditya Chavan, has alleged that Sitharaman and her department orchestrated extortion through electoral bonds. The Special Court for Pardon & Representation, after reviewing the case, ordered the Thakur Nagar police station to register an FIR. 'Our allegation is that Nirmala Sitharaman is misusing her position as finance minister to benefit her party, which is ruled at the Centre. That is where extortion comes into the picture,' yer told. He described the electoral bond scheme as a scam that the entire nation was exposed to, emphasizing that their complaints and evidence demonstrate a clear-cut case of extortion and corruption by the union minister and her BJP colleagues in Karnataka as well. Further, he claimed that data uploaded by the State Bank of India (SBI) clearly shows how the extortion took place. 'We have filed 15 to 16 complaints at various police stations, but right now we are following up on only one - the one where the court has directed that an FIR be filed at Thakur Nagar Police Station against Nirmala Sitharaman and others. The Special Court declared electoral bonds unconstitutional in February 2024. The scheme allegedly enabled political parties to receive large sums of money without disclosing the identity of donors, raising concerns about corporate influence in politics. The complaint, originally submitted by JSP in April 2024 at the 42nd
